Once at the Clark County Detention Center, Mr. Brooks attests that he was misidentified, resulting in Mr. Brooks to be detained longer than necessary; and, if appropriate, to privately consider and vote upon the findings and recommendations to be made to the department regarding any disciplinary action against the officers.
